



Active Medical Waste Facilities in Texas

Medical waste in Texas must be treated at an authorized treatment facility prior to transport to a permitted municipal solid waste Type I or IAE landfill for disposal.

Use the tables in this document to find locations and information about facilities that may accept medical waste for treatment, or for transfer to another authorized facility. Table 1 lists active medical waste treatment facilities, some which also function as transfer stations; Table 2 lists active medical waste facilities that function only as transfer stations. Facility types include:

- 5AC Medical waste autoclave facility
- 5MW Medical waste processor
- 5WI Incinerator
- 5MWTS Medical waste transfer station
